Instructions for Academic Year 2019-2020 Application

Eligibility requirements - Applicants must be one of the following:

- child (under age 23 on May 1, 2019) of an active duty, retired (including retired Reservist drawing military retirement pay) or deceased (died on active duty or after retirement) Sailor or Marine
- spouse of an active duty or retired Sailor or Marine
- MECEP/MECP student

All students must be:

- registered in DEERS (Defense Eligibility Enrollment Reporting System)
- enrolled, and registered, as a full-time student for the entire academic year (Aug-May) at the same institution and pursuing first undergraduate degree at a post-secondary, technical, or vocational institution that is:
 - Located in the United States
 - Accredited by a regional/national accrediting agency recognized by the U.S. Secretary of Education
 - A participant in the U.S. Department of Education Title IV Financial Aid Programs
- Agree to maintain a cumulative GPA of 2.0 or better on a 4.0 grade scale while receiving NMCRS financial assistance
- DEMONSTRATE FINANCIAL NEED

Program details:

- Interest free loans and grants range from \$500 to \$3,000 per academic year
- NMCRS will determine the amount of each award
- Funds are payable and provided to the student's academic institution, not the student
- Funds are to be used only for tuition, books, fees, room, and board
- Repayment of interest free loans must begin September 1, 2019 by military payroll allotment or EFT and paid within 24 months of the loan disbursement.

Application Process: Students must complete a new application for each academic year

Step 1: Complete and submit pages 3 & 4 of NMCRS 2019-20 application

Read instructions and application process carefully!

Step 2: Submit eligibility verification documents:

- **All applicants must submit copies of the student and sponsors current military ID card (front & back).**
 - (DODI 1000.13 Enclosure 3 Guidelines and Restrictions 2a permits photocopying ID for the purpose "of administering other military related benefits to eligible beneficiaries.")
- If the sponsor is retired must submit a copy of DD214
- If the sponsor is deceased must submit a copy of DD1300 Report of Casualty and a copy of death certificate
- If MECEP/MECP student submit copy of Board Results and transfer orders

SUBMISSION DEADLINE: MAY 1, 2019

Step 3: Submit official transcript(s): Transcript may be submitted by the institution by email to education@nmcrs.org . Transcripts must have official school stamp –no copies will be accepted.

- If the applicant is a rising college freshman (never attended college), send official high school transcripts through December 2018
- If the applicant is attending a college/university/vocational institution, send official transcripts of all college credit courses thru fall semester 2018
- Must have a cumulative GPA of 2.0 on a 4.0 scale

Step 4: Submit the Student Aid Report (SAR) portion of the FAFSA (Free Application for Federal Student Aid): The SAR provides the Expected Family Contribution (EFC) number used in determining your need for education assistance. **You must resolve any SAR issues before submitting it to NMCRS. For example:**

- Line items marked with “h”
- EFC number has an *
- EFC number is blank

COMPLETE SAR is required, should be 4 to 5 pages.

Step 5: Do you have the following documents?

- Application (do not send instructions)
- Official transcripts
- Supporting documents
- SAR
